In fact, the production could have been even higher but for a disturbance at Lingaraj of MCL.

CIL's production started a path of healthy recovery from October 2019 onward. Against 240.93 MT in the first half of 2019-20, the company produced 276.85 MT in the next five months from October 2019 to February 2020.



Coal India touches a new high in per day output making despatches an issue now

The company has peaked a high off producing 3.17 million tonne on March 20 this year, the highest ever single-day production, overtaking 3.14 MT that it produced on March 25 last year.



At a time when COVID-19 has hit most industrial operations and companies are forced to cut down on production, public sector miner Coal India (CIL)'s three lakh-odd workers are escalating productivity, which down the line has put despatches on pressure.

The company has peaked a high off producing 3.17 million tonne on March 20 this year, the highest ever single-day production, overtaking 3.14 MT that it produced on March 25 last year. Coal stocks to the country's power stations rose to its highest at 39.48 MT, which gives an average inventory of 23 days to the power producing units.

problem of plenty has now cropped up. Power plants, which lift the fuel from CIL subsidiary Central Coalfields (CCL), are refusing to take coal since these plants have already created stock piles of more than 35 days. These plants are now trying regulate receipts of the fuel, for which they have stopped paying.

A CIL official said while the blow has been to the CCL, the highest-producing subsidiaries have been Mahanadi Coalfields (MCL) and South Eastern Coalfields Ltd (SECL), which contributed 0.93 MT and 0.81 MT, respectively, to its single day's highest production. These two subsidiaries make for above 50% of CIL's production and any disturbances in these two subsidiaries become a cause of worry to CIL's productivity.

However, despite disturbances at Lingaraj in MCL, the subsidiary has been upbeat in its production. A CIL official said the coronavirus didn't have an impact on the productivity of the company because the miners are working as usual with the prescribed precautionary measures. Miners do not have to gather while mining and they generally operate in large areas without coming in contact to each other.

So the healthy recovery in productivity, that started from October last year onwards following slump due to prolonged monsoons, continued and production reached a new high. Against 240.93 MT in the first half of FY20, the mining behemoth produced 276.65 MT between October and February.

February witnessed a robust growth of 14.2% compared to the same month a year ago period. Coal production was 66.26 MT, the highest ever monthly production against 58.05 MT during the same month, a year ago. Coal offtake rose to 54.97 MT during February this fiscal, against 51.46 mt during the corresponding month last fiscal.

CIL loaded 256 rakes per day on an average during February this fiscal compared with 250.3 rakes loaded during February last fiscal. But, this situation has not gone down very well with CIL. Power sector consumers in order to regulate coal receipt have started filing lesser or no rail movement at all which has started increasing the pit head stock positions of CIL. The challenge going forward is to liquidate the stock since CIL has already cleared the pending rakes to both the power and non-power consumers, an official said, adding while pit head stock has started piling up, the company was yet to find out the quantum of stock.



Coal India postpones year-end coal stock measurement amid COVID-19 spread

This time, following spread of Corona Virus, the exercise will be completed on April 27. According to a notice issued by the company, physical stock measurement is to be completed within seven days, by April 22.



Kolkata: Coal IndiaNSE 1.44 % has postponed its annual stock measurement from April 1 to April 15, following advisory issued by the government and cancellation of train movement due to threat posed by outbreak of pandemic COVID-19.

Every year, the company engages an external agency to take stock of inventory at some 360odd mines operated by its seven coal producing subsidiaries. The exercise is related to ascertaining annual accounts of the company.

This time, following spread of Coronavirus, the exercise will be completed on April 27.

According to a notice issued by the company, physical stock measurement is to be completed within seven days, by April 22. Reports will have to be submitted to subsidiaries by April 25 and final report has to be submitted to Coal India by April 27.

Coal India is also working on the possibility of using drone to measure its inventory to accumulate data faster. The project was postponed as an initiative to stop leakages and strengthen the company's balance-sheet. Over-reporting in production has an inflationary effect on the company's earnings.

Power, coal, renewable energy exempted from lockdown

THE GOVERNMENT HAS exempted movement of personnel and equipment related to power generation and transmission from country-wide lockdown.

According to separate notifications released by the Union ministries of power and renewable energy, exemptions have been granted from "Section 144, nationwide lockdown, or any other such limitations" to enable requisite manpower and ensure uninterrupted operations of power generating stations and electricity transmission networks.

The coal ministry had issued a similar notification on March 23, but coal mining operations had faced interruptions in certain parts of the country even after that. To prevent such issues, the Ministry of Home Affairs on Wednesday issued an addendum to its earlier order on the lockdown under the Disaster Management Act, and clarified that coal mining and associated operations are exempted from such restrictions.



To benefit its non-power consumers, Coal India (CIL) has requested the railways to defer loading of rakes for non-power consumers without own unloading systems inside their plants. CIL has also extended the payment date for successful bidders buying through eauctions. It is also said to be rescheduling e-auctions scheduled during the lockdown period.

All under-construction renewable energyprojects will be allowed time extension considering the period of lockdown and the time required for remobilisation of work force, Aanand Kumar, secretary, Ministry of New and Renewable Energy (MNRE) said on Twitter.

The MNRE, on March 20,

had announced that "delay on account of disruption of the supply chains due to spread of coronavirus in China or any other country" would be seen as a force majeure event. Project developers will not have to pay any penalty for missing commissioning deadlines, if they can prove that consignments got delayed by global restrictions in freight movements stemming from Covid-19.

"Restarting the supply chain for materials and mobilising manpower will be a time-consuming affair once the world gets back on its feet, and a blanket extension of 6 months for all under-construction renewable energy projects will go a long way in protecting the industry from the adverse impact of this pandemic," Sumant Sinha, CMD, ReNew Power, said.

Welcoming the exemption for solar plants, Puneet Goyal, co-founder of SunAlpha Energy,said, "These plants supply power even in situations where conventional power plants like coal and natural gas may not be able to operate due to logistics constraints." Date: 27.03.20

Lockdown: CIL relaxes payment terms, reschedule e-auctions

Kolkata, Mar 26 () To protect interests of its consumers, Coal India Ltd on Thursday said it has relaxed payment terms and directed the railways to defer loading of rakes for non-power buyers due to last-mile connectivity disruption following the nation wide lockdown.

The world's largest miner has also directed its subsidiary companies to extend the date for payment by successful bidders in e-auctions, in case it falls within the lockdown period.

"CIL is helping its non-power customers overcomelast-mile connectivity issues they are facing due to then ation wide lockout declared to contain the Covid-19 outbreak," a top Coal India official told.

CIL has requested Indian Railways to defer coalloading of rakes for nonpower consumers who do not have theirown unloading system inside their plants or have to unloadrakes at other sidings.

"In the prevailing situation, many non-power consumershave approached CIL requesting deferring of loading of theirallotted rakes," the official said.

The situation will be reviewed after the lockdown is withdrawn, he said.

The official said CIL is also changing the time of various e-auction schemes which were scheduled during the lockdown period.
