In case their performance during the probation/extended probation period are not found satisfactory, they may be reverted to their respective substantive post held by them before appointment / promotion in E2 Grade
- 3.The promotion /appointment of above employees will be effective on and from the date they assume charge of the higher post at their new place of posting to be decided by the Chairman-cum-Managing Director of the respective company where they have been posted on promotion/appointment. On being released from the present company, they will report for duty to the concerned CMD immediately

- 4.The terms & conditions of their appointment/promotion will be in accordance with the rules/orders framed / issued from time to time as applicable in respect of executive cadre employees of Coal India Limited.
- 5.On promotion/appointment to the post of Sr.Officer(Secretarial), the above employees will be governed by the Conduct, Discipline & Appeal Rules 1978 as amended from time to time.
- 6. The seniority position of the above employees in E2 Grade will be determined according to the position assigned to them in the selection panel.
- 7. The above employees will furnish their original certificates in support of their educational /professional qualifications, caste etc. for verification and submit the attested photocopies of each at the time of joining at the new place of posting for verification and records and in case anything is found adverse they will be liable for disciplinary action as per extant rules of the company
